The A127 London-Southend Trunk Road (Rayleigh Weir Improvement) Slip Roads Order 1988

The A127 London-Southend Trunk Road (Rayleigh Weir Improvement) Side Roads Order 1988

The Secretary of State for Transport hereby gives notice that he has made the following Orders:

- (1) an Order under sections 10 and 41 of the Highways Act 1980 which will provide that four slip roads to connect the A127 London-Southend Trunk Road with existing routes by means of a new roundabout which he intends to construct at Rayleigh Weir in the county of Essex shall become trunk roads as from the date when the Order comes into operation; and
- (2) an Order under sections 12, 14 and 125 of the Highways Act 1980 authorising him to:
 - (a) improve, raise, lower or otherwise alter highways,
 - (b) stop up a highway,
 - (c) construct new highways,
 - (d) stop up private means of access to premises, and
 - (e) provide new means of access to premises,

all at Rayleigh Weir, on or in the vicinity of the route of the A127 Trunk Road and the new trunk roads mentioned above, and providing for the transfer of those of the new highways which will not be temporary to the County Council of Essex as from the date on which he notifies the Council that the new highways have been completed and are open for through traffic. The Order as made embodies part of the proposals contained in the Order published in draft by the Secretary of State on 21st August 1986 under the same title. The Secretary of State is deferring consideration of the remaining part of those proposals which relate to the footbridge.
