## DEPARTMENT OF TRANSPORT

### TOWN AND COUNTRY PLANNING ACT 1971

The Secretary of State for Transport hereby gives notice that he has made an Order under section 209 of the above Act, entitled "The Stopping Up of Highways (County of Hampshire) (No. 9) Order 1988", authorising the stopping up of the whole length of Sea Mill Path, part of the footway and carriageway on the south-eastern side of St. George's Way north-eastwards from its junction with Dean Street, part of the footway on the south-eastern side of Britain Street south-westwards from its junction with Dean Street, a section of carriageway, 4.5 metres long, at the junction of St. George's Way and Britain Street, opposite its junction with Dean Street and the whole length of Dean Street at Portsea in the City of Portsmouth, in the County of Hampshire.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the power of the above Act or that any requirement of that Act or of any Regulation made thereunder has not been complied with in relation to the Order may, within 6 weeks of 27th July 1988, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
