The Stopping-up of Highways (George Street, Llandudno) Order 1988

The Secretary of State for Wales hereby gives notice that he has made the above Order under section 209 of the Town and Country Planning Act 1971 to authorise the stopping-up of the highway described in the Schedule to this notice to enable development to be carried out.

Copies of the Order may be inspected free of charge at all reasonable hours at the offices of Aberconwy Borough Council, Town Hall, Llandudno.

If any person desires to question the validity of the Order, or of any provision contained therein, on the grounds:

(a) that it is not within the powers of the Town and Country Planning Act 1971; or

(b) that his interests have been substantially prejudiced by a failure to comply with any of requirements of that Act,

he may within 6 weeks of 28th July 1988, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

SCHEDULE

(All distances are approximate)

The highway to be stopped-up is at Llandudno in the County of Gwynedd and is that length of highway known as George Street which extends from Market Street in a general south-easterly direction for a distance of 104 yards. (1 SI)

The Trunk Road (A487) (North Road, Aberaeron, Dyfed) (Prohibition of Waiting) Order 1988

Notice is hereby given that the Secretary of State for Wales proposes to make an Order under sections 1, 2 and 4 of the Road Traffic Regulation Act 1984.

The effect of the proposed Order will be to prohibit (with certain exceptions) the waiting of vehicles on the side of the Fishguard-Bangor Trunk Road (A487) specified in the Schedule to this notice between the hours of 9 a.m. and 6 p.m. on any day.

A draft Order, together with a plan and statement of reasons for making the Order, may be inspected during normal office hours at the offices of Ceredigion District Council, Town Hall, Aberystwyth.

Objections, specifying the grounds on which they are made, and quoting ref. WR15/2/285, must be sent in writing to the Welsh

Office, Highways Directorate, Roads Administration Division, Government Buildings, Ty Glas Road, Llanishen, Cardiff CF4 5PL, by 18th August 1988. In the preparation of an objection and the statement of grounds of objection, it should be borne in mind that the substance of any objection or representation may be communicated to other people who may be affected by it.

The north-west side of the Fishguard-Bangor Trunk Road (A487) known as North Road at Aberaeron in the County of Dyfed, which extends from a point 15 metres south-west of the junction of the Trunk Road with Oxford Street to a point 15 metres north-east at the said junction. (2 SI)

The New Towns of Warrington and Runcorn, Extinguishment of Public Rights of Way Barrow Hall Lane, Great Sankey, Warrington.

Notice is hereby given that the Secretary of State for the Environment in exercise of his powers under section 23 of the New Towns Act 1981, has made an Order extinguishing as from the date of the Order the public rights of way over the following right of way shown on the map hereinafter referred to:

That part of Barrow Hall Lane starting from a point marked B on the map (located 7.41 metres to the north of the northern boundary of "Eldon Lea") and running in a northerly direction for a distance of 190.67 metres to a point marked A on the map (located on the eastern kerb-line of Barrow Hall Lane at the boundary gate to the former Burtonwood Air Base).
