CAMBRIDGESHIRE COUNTY COUNCIL

The County of Cambridgeshire (Hartford Road, Huntingdon) (Residents Parking Place) (Prohibition and Restriction of Waiting) Orders 1988.

Notice is hereby given that on 21st July 1988, the Cambridgeshire County Council made an Order under sections 1(1) and (2), 2(1) to (3), 45, 46, 49 and 53 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic Regulation (Parking) Act 1986 and of all other enabling powers the effect of which is:

- (i) to designate the length of road specified in the schedule below as a parking place, for residents of that part of Hartford Road between Nursery Road and High Street, between 8 a.m. and 6 p.m. Monday to Saturday;
- (ii) to restrict waiting to 1 hour in any 2 hours between 8 a.m. and 6 p.m Monday to Saturday on part of the north-west side of Hartford Road;
- (iii) to prohibit waiting between 8 a.m. and 6 p.m. on any day on both sides of Hartford Road in the vicinity of the fire station.

The Parking Place Order restricts the use of the parking place to residents' cars displaying a permit.

There is a £15 annual administration charge for residents permits which will only be issued to residents of that part of Hartford Road between Nursery Road and High Street.

The provisions of the Parking Place Order do not empower the Council to allocate parking places to individual residents. The granting of a permit does not guarentee that space will always be available in the parking place.
