

SURREY COUNTY COUNCIL

Surrey County Council (Various Roads in Baldwins Hill, Dormansland, Felbridge, Godstone, Lingfield, South Nutfield and Woldingham) (Restricted Roads) Order 1988.

Notice is hereby given that on 27th July 1988 the Surrey County Council made an Order under sections 82 and 83 of and Parts III and IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("The Act") and of all other enabling powers the effect of which is as described in the notice (ref. 513) which appeared in the edition of the *London Gazette* dated Thursday, 14th April 1988, the issue number of which was 51303.

The Order will come into operation on 1st August and can be inspected together with plans showing the roads and lengths of roads to which it relates at the Information Centre of the County Secretary and Solicitor's Department (Room 122), County Hall, Penrhyn Road, Kingston-upon-Thames, between 10 a.m. and 4 p.m. from Mondays to Fridays.

Any person wishing to question the validity of the Order, or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of the Act or of any Instrument made under it has not been complied with in relation to the Order may within 6 weeks from the date of the Order apply to the High Court for this purpose.

THAMESDOWN BOROUGH COUNCIL

The Borough of Thamesdown (Parking Places) (Pay and Display) (Amendment) Order 1988

Notice is hereby given that the Thamesdown Borough Council propose to make an Order under sections 35 and 124 of the Road Traffic Regulation Act 1984, and of all other enabling powers, the effect of which is to amend the Borough of Thamesdown (Parking Places) (Pay and Display) Order 1984 (hereinafter referred to as "the 1984 Order") as follows:

- To introduce the undermentioned revised charges for the parking of vehicles at the parking places in Swindon comprised in the 1984 Order including North Star Car Park, levels 1, 2 and 3 Carlton and levels 1, 2, 3 and 4 Fleming Way Car Parks.
- To withdraw the special season ticket available in respect of the North Star Car Park.
- To permit Long Stay (yellow code) season tickets to park in Floor 2 B of the Carlton Car Park and Floor 3 of the John Street Car Park.
- To include within the provisions of the 1984 Order (as amended) a temporary car park at Curtis Street, Swindon, for all classes of vehicle not exceeding 30 cwt. unladen weight.
- To include within the provisions of the 1984 Order (as amended) a temporary car park at Bristol Street, Swindon, for all classes of vehicle not exceeding 30 cwt. unladen weight and 2.03 metres (6 feet 9 inches) in height.

The Borough of Trafford (Urmston Lane/Ryecroft Road, Stretford) (Prohibition of Waiting) Order

Notice is hereby given that the Trafford Borough Council propose to make an Order under sections 1 and 2 of the Road Traffic Regulation Act 1984. The effect of the Order will be to prohibit waiting at any time as follows:

Urmston Lane, Stretford, south side, from the westerly kerb-line of Ryecroft Road for a distance of 15 metres in a westerly direction.

Ryecroft Road, Stretford, west side, from its junction with Urmston Lane for a distance of 38 metres in a southerly direction.

Ryecroft Road, Stretford, east side, from a point 15 metres south of its junction with Urmston Lane for a distance of 23 metres.

The Borough of Trafford (Walton Road/Marsland Road, Sale) (Prohibition of Waiting) Order

Notice is hereby given that the Trafford Borough Council propose to make an Order under sections 1 and 2 of the Road Traffic Regulation Act 1984. The effect of the Order will be to prohibit waiting at any time as follows:

Walton Road, both sides, from a point 45 feet (13.71 metres) south of the junction with Marsland Road, for a distance of 16.29 metres in a south-westerly direction (i.e. a total length of 30 metres from junction).
