### DEPARTMENTS OF THE ENVIRONMENT AND TRANSPORT

#### HIGHWAYS ACT 1980

#### *Acquisition of Land Act 1981*

Notice is hereby given that Public Local Inquiries in connection with the Orders mentioned below will be held by Brigadier R. G. Harmer F.C.I.T. (a person appointed for the purpose by the Secretaries of State for the Environment and Transport on the nomination of the Lord Chancellor) beginning at 10 a.m. on Wednesday, 14th September 1988, at the Chase Hotel, Hensingham, to hear representations from statutory objectors (as defined in the Highways (Inquiries Procedure) Rules 1976 so far as concerns the draft Orders specified at A to D below, and in the Compulsory Purchase by Ministers (Inquiries Procedure) Rules 1967 so far as concerns the draft Order specified at E below) and, at his discretion, to hear representations from any other persons who may desire to appear and be heard.

The Orders which have been prepared in draft by the Secretary of State for Transport under the above mentioned Acts are:

(A) The Levens Bridge—Carlisle Trunk Road (A595 Hensingham By-pass) Order 198 , notice of which was published on 17th November 1987. This is an Order under sections 10 and 14 of the Highways Act 1980 which, if made, will provide that a new highway about 1.05 kilometres in length, which the Secretary of State for Transport proposes to construct between a point 65 metres south of the junction of Loop Road South and Inkerman Terrace and a point immediately north of the junction of Egremont Road and Homewood Road, shall become a trunk road.

(B) The Levens Bridge—Carlisle Trunk Road (A595 Hensingham By-pass) (Detrunking) Order 198 , notice of which was published on 17th November 1987. This is an Order under sections 10 and 12 of the Highways Act 1980 which, if made, will provide that the length of the A595 Trunk Road described in the Schedule to that Order shall cease to be a trunk road and shall be a classified road (for which the County Council of Cumbria will be the highway authority).

(C) The Levens Bridge—Carlisle Trunk Road (A595 Hensingham By-pass) (Side Roads) Order 198 , notice of which was published on 17th November 1987. This is an Order under section 12 and 14 of the Highways Act 1980 which, if made, will authorise the Secretary of State for Transport:

- (a) to carry out the improvement of highways,
- (b) to stop up highways,
- (c) to construct new highways,
- (d) to stop up private means of access to premises, and
- (e) to provide new means of access to premises,

all at Hensingham in the County of Cumbria, and will provide for the transfer of each of those new highways, two of which shall be classified as classified roads, to the County Council of Cumbria.

(D) The Levens Bridge to Carlisle Trunk Road (A595 Hensingham By-pass) (Side Roads) (No.2) Order 198 , notice of which was published on 11th April 1988. This is an Order under sections 14 and 125 of the Highways Act 1980 which, if made, will authorise the Secretary of State for Transport:

- (a) to stop up private means of access to premises, and
- (b) to provide new means of access,

all at Hensingham in the County of Cumbria.

(E) The Levens Bridge—Carlisle Trunk Road (A595 Hensingham By-pass) Compulsory Purchase Order (No. NW) 198 , notice of which was published on 11th May 1988. This is an Order under sections 239, 240 and 246 of the Highways Act 1980 as extended and supplemented by section 250 of that Act and under section 2 of the Acquisition of Land Act 1981 which, if made, will authorise the Secretary of State for Transport to purchase compulsorily the land and rights described therein for the purposes of:

- (a) the construction of the new highway referred to at A above;
- (b) the construction and improvement of highways and the provision of new means of access to premises in pursuance of the Orders specified at C and D above;
- (c) the improvement of the existing Trunk Road in the town of Whitehaven in the Borough of Copeland in the County of Cumbria;
- (d) the diversion of watercourses and the execution of other works on watercourses in connection with the construction and improvement of highways and the execution of other works mentioned above;
- (e) use by the Secretary of State in connection with such construction and improvement of highways and the execution of other works mentioned above; and
- (f) mitigating any adverse effect which the existence or use of the highways proposed to be constructed or improved

by him as mentioned above will have on the surroundings thereof.

Copies of the above-mentioned draft Trunk Road, Detrunking, Side Roads and Compulsory Purchase Orders and of the plans referred to therein have been deposited, and may be seen at all reasonable hours free of charge, at the Department of Transport, North West Regional Office, Sunley Tower, Piccadilly Plaza, Manchester M1 4BE; and the offices of Copeland Borough Council, Catherine Street, Whitehaven, Cumbria.

Proceedings on the above-mentioned draft Orders are being taken concurrently by virtue of section 257 of, and paragraph 20 of Schedule 1 to the Highways Act 1980.

Objectors are reminded that the substance of their objections or representations may be communicated to other people who may be affected by them; that they will be passed to the Inspector holding the Inquiries; and that in that event the Inspector may be required to disclose the objections or representations at the Inquiries and, unless there are special reasons to the contrary, the identity of the authors.

The Secretaries of State for the Environment and Transport hereby direct that any person who intends at the Inquiry to submit that any highway or proposed highway to which the draft Orders or any of them relate should follow an alternative route, or that, instead of improving, diverting or altering a highway to which the draft Orders, or any of them relate, a new highway should be constructed on a particular route, shall send to the Secretary of State for Transport, at the North West Regional Office, Sunley Tower, Piccadilly Plaza, Manchester M1 4BE, not later than 31st August 1988, sufficient information about the alternative route to enable it to be identified. Failure to comply with this Direction will entitle the Secretaries of State, and the person holding the Inquiries, to disregard so much of any objection as consists of such a submission.
