For Calling a New Parliament.

ANNE R.

Whereas by our Royal Proclamation, bearing Date the Eighth Day of this Month of August, We did Dissolve the last Parliament, and Declared our Intentions of Speedily Calling a New One; We do, accordingly hereby further Declare, That, with the Advice of Our Privy Council, We have this Day given Order to Our Chancellor of Great Britain, to Issue out Writs in due Form for the Calling a New Parliament; which Writs are to bear Teste the Eighteenth Day of this Instant August, and to be Returnable on Thursday the Twelfth Day of November next following.

Given at our Court at Windsor, the Seventeenth Day of August, 1713. In the Twelfth Year of Our Reign.

A PROCLAMATION,

In order to the Electing and Summoning the Sixteen Peers of Scotland.

ANNE R.

Whereas We have in Council thought fit to Declare Our Pleasure for Summoning and Holding a Parliament of Great Britain, on Thursday the Twelsth of November next ensuing the Date hereof: In order therefore to the Electing and Summoning the Sixteen Peers of Scotland, who are to Sit in the House of Peers in the said Parliament, We do, by Advice of Our Privy Council, Issue forth this Our Royal Proclamation, strictly Charging and Commanding all the Peers of Scotland to Assemble and Meet at Our Royal Palace of Holy-Rood House in Edinburgh, on Thursday the Eighth Day of October next ensuing, between the Hours of Twelve and Two in the Asternoon, to Nominate and Chuse the Sixteen Peers to Sit and Vote in

the House of Peers in the said ensuing Parliament, by Open Election and Plurality of Voices of the Peers that shall be then present, and of the Proxies for such as shall be Absent, such Proxies being Peers, and producing a Mandate in Writing, duly Signed before Witnesses, and both the Constituent and Proxy being Qualified according to Law. And the Lord Cierk Register, or such Two of the Principal Clerks of the Session, as shall be appointed by him to Officiate in his Name, are hereby re-spectively Required to Attend such Meeting, and to Administer the Oaths Required by Law to be Taken there by the said Peers, and to take their Votes, and immediately after such Election made, and duly examined, to Certifie the Names of the Sixteen Peers so Elected, and Sign and Attest the same in the presence of the said Peers the Electors, and Return such Certificate into our High Court of Chancery of Great Britain. And We strictly Charge and Command, That this Our Royal Proclamation be duly Published at the Market-Cross at Edinburgh, and in all the County-Towns of Scotland, Twenty five Days at least before the time hereby Appointed for the Meeting of the said Peers to Proceed to such Election.
