

REDBRIDGE LONDON BOROUGH COUNCIL

The Redbridge (Chigwell Road) (Prescribed Routes) (No. 10) Traffic Order 1988

Notice is hereby given that the Council of the London Borough of Redbridge on 28th October 1988 made an Order under section 6 of the Road Traffic Regulations Act 1984.

The general effect of the Order is to impose one way working for vehicular traffic from south-east to north-west on that length of Chigwell Road which lies between No. 704 to No. 720 Chigwell Road and runs on the north-west side of the triangular island at the Chigwell Road/Manor Road junction and to ban all vehicular traffic from turning into that length of Chigwell Road from its junction with No. 720 and the north-west side of the triangular island at the Chigwell Road/Manor Road junction.

The above-mentioned prohibition does not apply in respect of anything done:

- (a) with the permission or at the direction of a police constable in uniform;
- (b) in accordance with any restriction or requirement indicated by traffic signs placed on the Highway by or on behalf of the Metropolitan Police.

A copy of the Order which comes into operation 7th November 1988 and the Council's statement of reasons may be inspected during normal office hours at the Information Centre, Town Hall, High Road, Ilford, Essex, until 18th November 1988.
