A PROCLAMATION

*Altering the Proclamation of the 11th February 1983 Determining the Designs for One Pound Silver Coins*

ELIZABETH R.

Whereas under section 3(1)(b) and (h) of the Coinage Act 1971 We have power, with the advice of Our Privy Council, by Proclamation to determine the design of any coin to be made at Our Mint and to revoke or alter any Proclamation previously made under the said section:

And Whereas by Our Proclamation dated the eleventh day of February 1983 We ordered that new coins of silver of the denomination of one pound should be made at Our Mint:

And Whereas by Our Proclamation dated the seventeenth day of April 1985 We altered section 2 of Our said Proclamation of the eleventh day of February 1983 to determine new designs for the said one pound coins:

And Whereas it appears to Us desirable to determine new designs for the said one pound coins:

We, therefore, in pursuance of the said section 3(1)(b) and (h) and of all other powers enabling Us in that behalf do hereby, by and with the advice of Our Privy Council, proclaim, direct and ordain as follows:

1. The following section shall be substituted for section 2 of Our said Proclamation of the eleventh day of February 1983:

"2. The designs for the said coins shall be as follows:

For the obverse impression Our effigy with the inscription "ELIZABETH II D.G. REG.F.D." and the date of the year, and for the reverse either

(a) a Shield of Our Royal Arms ensigned by a representation of Our Royal Crown,

(b) the Ensigns Armorial of Our United Kingdom of Great Britain and Northern Ireland,

(c) an Oak tree enfiling a representation of Our Royal Diadem,

(d) a Thistle eradicated enfiling a representation of Our Royal Diadem,

(e) A Leek eradicated enfiling a representation of Our Royal Diadem, or

(f) A Flax Plant eradicated enfiling a representation of Our Royal Diadem .

and beneath the same the words "ONE POUND". The coins shall have a graining upon the edge and in incuse letters the inscription "DECUS ET TUTAMEN" or, in the case of the

coins bearing the impression of a Thistle, "NEMO ME IMPUNE LACESSIT" or, in the case of the coins bearing the impression of a Leek, "PLEIDIOL WYF I'M GWLAD".

2. Our said Proclamation of the seventeenth day of April One thousand nine hundred and eighty-five shall be revoked and this Proclamation shall come into force on the twenty-seventh day of October One thousand nine hundred and eighty-eight.

Given at Our Court at Buckingham Palace, this twenty-sixth day of October in the year of our Lord One thousand nine hundred and eighty-eight and in the thirty-seventh year of Our Reign.

### HIGHWAYS ACT 1980

#### ACQUISITION OF LAND ACT 1981

Notice is hereby given that the Public Local Inquiries in connection with the Orders mentioned below will be held by Brigadier R. G. Harmer FCIT (a person appointed for the purpose by the Secretaries of State for the Environment and Transport on the nomination of the Lord Chancellor) beginning at 10.00 a.m. on Tuesday, 29th November 1988 at Allerdale District Council, Divisional Offices, Wigton, to hear representations from statutory objectors (as defined in the Highways (Inquiries Procedure) Rules 1976, so far as concerns the draft Orders specified at A to C below and the Compulsory Purchase by Ministers (Inquiries Procedure) Rules 1967, so far as concerns the draft Order specified at D below) and, at his discretion to hear representations from any other persons who may desire to appear and be heard.

The orders which have been prepared in draft by the Secretary of State for Transport under the above mentioned Acts are:

- (A) Levens Bridge-Carlisle Trunk Road (A596 Wigton Bypass) Order 198 , notice of which was published on 4th March 1988. This is an Order under sections 10 and 41 of the Highways Act 1980 which if made will provide that a new highway about 3.69 kilometres in length which he proposes to construct between the junction of the existing A596 approximately 70 metres west of Church Rigg and a point 110 metres north-east of the junction with the U2066 at Smithfield Bridge in the County of Cumbria shall become a trunk road.
- (B) Levens Bridge-Carlisle Trunk Road (A596 Wigton Bypass) (Detrunking Order) 198 , notice of which was published on 4th March 1988. This is an Order under sections 10 and 12 of the Highways Act 1980 which if made will provide that the length of the A596 Trunk Road described in the Schedule to that Order shall cease to be a trunk road and shall be a classified road (for which the County Council of Cumbria will be the highway authority).
- (C) Levens Bridge-Carlisle Trunk Road (A596 Wigton Bypass) (Side Roads) Order 198 , notice of which was published on 4th March 1988 which, if made, will authorise the Secretary of State for Transport—
- to carry out the improvement of highways;
  - to stop up highways;
  - to construct new highways;
  - to stop up private means of access to premises; and
  - to provide new means of access to premises

all at Wigton in the District of Allerdale in the County of Cumbria.

- (D) The Compulsory Purchase Order (No NW ) 198 , Levens Bridge to Carlisle Trunk Road (A596 Wigton Bypass) Order 198 , notice of which was published on 14th April 1988. This is an Order under sections 239, 240, 246 of the Highways Act 1980 as extended and supplemented by section 250 of that Act and under section 2 of the Acquisition of Land Act 1981 which, if made, will authorise the Secretary of State for Transport to purchase compulsorily the various lands and rights described therein for the purposes of:
- the construction of the road referred to in A above;
  - the construction and improvement of highways and the provision of new means of access to premises in pursuance of the Order specified at C above;
  - the improvement of the Levens Bridge to Carlisle Trunk Road in the said District and County;
  - the diversion of watercourses and the execution of other works on watercourses, and use by the Secretary of State, in connection with the construction and improvement of highways and the execution of other works mentioned;
  - the mitigation of any adverse effect which the existence or use of those highways proposed to be constructed or improved by him will have on the surroundings thereof; and being given in exchange for land which he has acquired and which forms part of an open space.

3. Copies of the above mentioned draft Trunk Road, Detrunking, Side Roads and Compulsory Purchase Order and of plans referred to have been deposited and may be seen at all reasonable hours free of charge, at the Department of Transport, North West Regional Office, Sunley Tower, Piccadilly Plaza, Manchester M1 4BE; the Departments of the

Environment and Transport, 2 Marsham Street, London, S.W.1, and of the Cumbria County Council, The Courts, Carlisle; Allerdale District Council, Divisional Office, South End, Wigton; the Wigton Town Council, Wigton Community Centre, High Street, Wigton and the Wigton Public Library, High Street, Wigton.

4. Proceedings on the above mentioned draft Orders are being taken concurrently by virtue of section 257 and paragraph 20 of Schedule 1 to the Highways Act 1980.
5. Objectors are reminded that the substance of their objections or representations may be communicated to other people who may be affected by them; that they will be passed to the Inspector holding the inquiry; and that in that event the Inspector may be required to disclose the objections or representations at the inquiries and unless there are special reasons to the contrary, the identity of the authors.
6. The Secretaries of State for the Environment and Transport hereby direct that any person who intends at the Inquiry to submit that any highway or proposed highway to which either of the draft Orders at A and C relates should follow an alternative route or that, instead of improving, diverting or altering a highway to which either of those draft Orders relates, a new highway should be constructed on a particular route shall send to the Secretary of State for Transport, North West Regional Office, Sunley Tower, Piccadilly Plaza, Manchester M1 4BE, not later than 14th November 1988 sufficient information about the alternative route to enable it to be identified. Failure to comply with this Direction will entitle the Secretaries of State, and the person holding the inquiries, to disregard so much of any objection as consists of such a submission.

THE PLANT HEALTH (GREAT BRITAIN) ORDER 1987 No. 1758

#### IMPORT LICENCE

*General Licence PHF/1192/32(108)*

The Minister of Agriculture, fisheries and food in respect of England, the Secretary of State for Scotland in respect of Scotland and the Secretary of State for Wales in respect of Wales, by this licence granted under Article 42 of the Plant Health (Great Britain) Order 1987 ("the Order") authorise the landing in Great Britain of consignments of Potatoes (*Solanum tuberosum* L) produced on an authorised farm in the Jutland region of Denmark for use as ware subject to all other provisions of the Order (except Schedule 3, part III item 51(2) and (8)(b)) and the conditions set out below.

#### Interpretation

Unless the context otherwise requires, the expressions used in this licence shall have the same meaning as in the Order.

#### Conditions

(1) Each consignment shall be accompanied by a Phytosanitary certificate in the form set out in Schedule 6 to the Order issued in accordance with the provisions of the Order.

(2) The Phytosanitary Certificate shall include the following additional declaration: "The potatoes have been officially tested in Denmark in accordance with Commission Decision 88/36/EEC (Official Journal L20, 26.1, p.33) and found free from *Corynebacterium sepedonicum* (the cause of the Potato Ring Rot)."

(3) The importer shall ensure that in advance of landing a certified copy of the Phytosanitary Certificate is received by an inspector where the potatoes are to be landed or conveyed following landing, at the appropriate address listed in the annex to this licence.

(4) The importer shall notify an inspector of the landing of the potatoes and inform him of the port of landing and of the address of the premises where the potatoes are, or will be, kept and give the inspector such other information relating to the potatoes as he may require.

(5) The importer shall ensure that the potatoes remain at the port of landing or at any of the premises separate and clearly identifiable from other potatoes until inspection and release or until their movement has otherwise been authorised by an inspector.

(6) The importer shall ensure that the potatoes are not treated prior to inspection and sampling.

(7) The importer shall ensure that all cleanings, waste potatoes, soil processing debris from storage bins, cleaning and processing plant and equipment and treatment equipment are disposed of in a manner which will avoid the risk of spreading plant pests or diseases.

(8) If the importer knows or has reason to suspect that any plant pest or disease which is not normally present in Great Britain exists on the imported potatoes or elsewhere on the premises, where the potatoes or elsewhere on the premises, where the potatoes are being or have been kept, he/she shall notify an inspector immediately.

(9) The importer shall give all reasonable assistance and facilities to an inspector to enable him to carry out such inspection as he may require and permit him to take samples of potatoes, plant pests or soil for scientific examination.

(10) The importer shall keep records of all potatoes landed under the authority of this licence. The records shall include details of the disposal of the potatoes. All records shall be produced to an inspector upon request.

(11) This licence may, at any time, be amended, suspended or revoked by the Minister in respect of England, the Secretary of State for Scotland in respect of Scotland and the Secretary of State for Wales in respect of Wales.
