## **ROAD TRAFFIC REGULATION ACT 1984**

#### The Trunk Road (A30) (Victoria, Roche) (De-restriction) (No.) Order 198

The M66 Motorway (Middleton to the Lancashire/Yorkshire Motorway (M62) Section) (Transfer of Highways) Order 1988

The Secretary of State for Transport hereby givens notice that he has made two Schemes and an Order under sections 16, 17, 18, 19 and 106 of the Highways Act 1980. These are:

(1) A Scheme under sections 16, 17, 18, 19 and 106 of the Highways Act 1980 authorising him:

(a) to provide for the exclusive use of traffic of Classes I and II of the classes of traffic set out in Schedule 4 to the Highways Act 1980:

(i) a special road about 16.1 kilometres in length starting in Denton in the Metropolitan Borough of Tameside at a point approximately 300 metres south of Manchester Road (A57), 100 metres east of the junction of Thompson Road and Harris Avenue and proceeding in a generally northerly then northwesterly direction and ending in Rhodes in the Metropolitan Borough of Bury at a point on the roundabout on Middleton Road (A576) at Rhodes approximately 325 metres north-west of the junction of Middleton Road (A576) and Heywood Old Road (A6045), and

(ii) 14 special roads to connect the above-mentioned Special road with Manchester Road (A57), Denton; a proposed all purpose road to connect Audenshaw Road (B6390), Audenshaw; Manchester Road (A635), Ashton-under-Lyne; Manchester Road (A62) and Hollins Road at Hollinwood; a proposed all purpose road to connect Hollinwood Avenue (A6104) with Broadway (A663), a proposed roundabout on Broadway (A663); and Middleton Road (A576) at Rhodes; and

(b) to construct as part of the first mentioned Special road a bridge over navigable waters of the Manchester and Ashton-under-Lyne Canal;

and providing for the said special roads to become trunk roads on the date when the Scheme comes into operation.

(2) A Scheme under sections 16 and 17 of the Highways Act 1980 authorising him:

(a) to provide for the exclusive use of traffic of Classes I and II of the classes of traffic set out in Schedule 4 to the Highways Act 1980:

(i) a special road, with diverging carriageways, about 1.6 kilometres in length in the Metropolitan Borough of Bury starting at Simister at a point on the north side of Simister Lane approximately 115 metres south-west of the junction of Simister Lane and Droughts Lane and proceeding in a generally southeasterly direction and ending at Rhodes at a roundabout junction with Middleton Road (A576) approximately 325 metres south-west of the junction of Middleton Road (A576) and Heywood Old Road (A6045); and

(ii) two special roads to connect the above-mentioned special road with a roundabout constructed as part of the M62 Motorway at Simister.

(3) An Order under section 18 of the Highways Act 1980 authorising him to transfer to himself as special road authority the special roads described at (2) above which were constructed by the Lancashire County Council but will become trunk roads as from the date the Order comes into operation.
