## NEWCASTLE-UPON-TYNE CITY COUNCIL

*The City of Newcastle-upon-Tyne (Elsdon Road, Hedley Street, Back Henry Street, Gosforth) Prohibition of Waiting Order 1988*

Notice is hereby given that the council of the City of Newcastle-upon-Tyne propose to make an Order under sections 1, 2 and 4 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984.

The effect of the proposed Order is to:

- (a) revoke the "No Waiting 8 a.m. to 6 p.m. Monday to Saturday" restriction on the west side of Elsdon Road from its junction with Back Salters Road to its junction with Henry Street and impose a "No Waiting 9 a.m. to 5 p.m. Monday to Saturday" restriction;
- (b) revoke the "No Waiting 8 a.m. to 6 p.m. Monday to Saturday" restriction on the west side of Hedley Street from its junction with Back Salters Road to its junction with Henry Street and impose a "No Waiting 9 a.m. to 5 p.m. Monday to Saturday" restriction;
- (c) impose a "No Waiting at any Time" restriction on both sides of Back Henry Street from its junction with Regent Road to the cul-de-sac to the east of Elsdon Road;
- (d) impose a "No Waiting at any Time" restriction on both sides of the unnamed road running between Back Henry Street and Henry Street.
