Road Traffic Regulation Act 1984

The District of Basildon (Station Lane, Pitsea) (Restriction of Waiting and Prohibition of Right Turns) Order 1988

Notice is hereby given that the District Council of Basildon, pursuant to arrangements made with the Essex County Council under section 101 of the Local Government Act 1972 and in exercise of the powers of the County Council under sections 1(1) and (2), 2(1) to (3), and 4(2) of the Road Traffic Regulation Act 1984 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to that Act have made an Order, the effects of which are:

(a) RESTRICTION OF WAITING

(i) No waiting between 8 a.m. and 6 p.m. Mondays to Saturdays

Station Lane, both sides from its junction with High Road, Pitsea, southwards for a distance of 20 metres.

Station Lane (dual carriageway) West Side, from the commencement of the dualled section at the northern and southwards for a distance of

35 metres with the exception of licensed hackney Carriages waiting in an authorised Cab Rank.

East Side, from the commencement of the dualled section at the northern end southwards for a distance of 20 metres.

(ii) Waiting limited to 30 minutes in any hour between 8 a.m. and 6 p.m. Mondays to Saturdays

Station Lane, both sides from a point 20 metres south of its junction with High Road, Pitsea, to its southernmost end, including the turning area.

(iii) No waiting between 6 a.m. and 8 p.m. Mondays to Saturdays (except heavy goods vehicles and public service vehicles) limited to 2 hours No Return in 4 Station Lane (dual carriageway)

West Side, in the layby from its southernmost end northwards for a distance of 50 metres.

East Side, from a point 20 metres south of the commencement of the dualled section at its northern end southwards for a distance of 30 metres.

(b) PROHIBITION OF RIGHT TURNS

To prohibit right turn movements out of Station Lane into High Road or into Station Lane from High Road.

A copy of the Order, together with plan relating to it and statement of reasons for making it may be examined at this office between 9 a.m. and 5.15 p.m. Mondays to Fridays.

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or any instrument made under it, has not been complied with in relation to the Order, you may within 6 weeks from 16th December 1988 apply to the High Court for this purpose.

All previous Orders restricting waiting in Station Lane have been revoked.

This Order will come into operation on 23rd December 1988.
