#### **WELSH OFFICE**

The Secretary of State for Wales hereby gives notice that, subject to the granting of planning permission under Part III of the Act for the mining of coal, he proposes to make an Order under Section 209 of the Town and Country Planning Act 1971 to authorise the stopping up and diversion of highways described in Schedules 1 and 2 to this notice

The proposed Order will require the provision of a new highway, which shall be the diversion, on completion of mining operations. The highway to be stopped up and the route of the diverted highway are shown on the relevant plan, copies of which, together with the draft Order, may be inspected free of charge at all reasonable hours at the offices of Taff Ely Borough Council, County Buildings, 11 Mill Street, Pontypridd, Mid Glamorgan, during 28 days from 30th December 1988.

Within the above-mentioned period of 28 days any person may by notice to the Welsh Office, Highways Directorate, Roads Administration Division, Government Buildings, Ty Glas Road,

Llanishen, Cardiff CF4 5PL (quoting ref. WR 15/5/284), object to the making of the Order. In the preparation of an objection it should be borne in mind that the substance of any objection of representation may be communicated to other people who may be affected by it.

#### SCHEDULE 1

The highway to be stopped up is at Llanharan in the County of Mid Glamorgan and is the entire length of highway known as Old Llanharan Road.

#### SCHEDULE 2

The highway to be diverted is at Llanharan in the County of Mid Glamorgan and is that length of the unclassified Brynna/Llanilid Road which extends from its junction with the A473 in a general southerly direction of a distance of 705 metres. (I SI)
