#### TOWN AND COUNTRY PLANNING ACT 1971

The Stopping up of Highways (Fforest Hill, Aberdulais, West Glamorgan) Order 198

The Secretary of State for Wales hereby gives notice that he proposes to make an Order under section 209 of the Town and Country Planning Act 1971 to authorise the stopping up of the highway described in the Schedule to this notice to enable development for which planning permission has been granted, to be carried out.

During the 28 days from 14th February 1989, copies of the draft Order and the relevant plan may be inspected free of charge at all reasonable hours at the Offices of Neath Borough Council, Civic Centre, Neath, West Glamorgan.

Within the above-mentioned period of 28 days any person may by written notice to the Welsh Office, Highways Directorate, Roads Administration Division, Government Buildings, Ty Glas Road, Llanishen, Cardiff CF4 SPL (quoting ref. WR15/8/137), object to the making of the Order. In the preparation of an objection, it should be borne in mind that the substance of any objection or representation may be communicated to other people who may be affected by it.

SCHEDULE

(all distances are approximate)

The highway to be stopped up is at Aberdulais in the county of West Glamorgan. It is shown by zebra hatching on the deposited plan and is that length of highway known as Fforest Hill which extends from a point 2.5 metres west of the boundary line between the graveyard and No. 2 Fforest Hill in a general westerly direction for a distance of 32.5 metres and a width varying between 0.7 metres at the western end and 1.2 metres at the eastern end. #### Stopping up of Highways at Chadderton

The Secretary of State for Transport hereby gives notices that on the application of Oldham Metropolitan Borough Council he has made an Order under section 209 of the above Act entitled "The Stopping up of Highways (Metropolitan Borough of Oldham) (No. 1) Order 1989" authorising the stopping up of a length of Granville Street and adjoining passageways at Chadderton.

Copies of the Order may be obtained, free of charge, on application to the office of the Department of Transport, North West Regional Office, Sunley Tower, Piccadilly Plaza, Manchester M1 4BE (quoting ref. NWRT 5083/41/22), and may be inspected at all reasonable hours at the offices of the Director of Legal Services, Civic Centre, West Street, Oldham.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the above Act or that any requirement of that Act or of any regulation made thereunder has not been complied with in relation to the Order, may, within 6 weeks of 14th February 1989, apply to the High Court for the suspension or quashing of the Order of any provision contained therein.
