WIGAN METROPOLITAN BOROUGH COUNCIL

Notice is hereby given, that the Wigan Borough Council in exercise of its powers under section 1 of the Road Traffic Regulation Act 1984 has made the following Orders:

Wigan Borough (Birkett Bank Terrace, Wigan) (Prohibition of Driving) Order 1988.

The effect of this Order is to prohibit driving in Birkett Bank Terrace, Wigan form Schofield Lane/Birkett Bank junction for a distance of 3 metres in a northerly direction.

Wigan Borough (Dodds Farm Bridge, Aspull, Wigan) (Weight Restriction) Order 1988.

The effect of the Order is to introduce a weight limit of 24 tonnes for vehicles using Dodds Farm Brdge, Aspull.

Wigan Borough (Poolstock Lane/Howden Drive, Wigan) (Prohibition of Waiting) Order 1988.

- (i) Poolstock Lane, Wigan, west side from a point opposite the northerly kerb-line in Howden Drive for a distance of 15 metres in a northerly direction.
- (ii) Howden Drive, Wigan, both sides from a point 15 metres east of Poolstock Lane for a distance of 15 metres in an easterly direction.

Wigan Borough (Orchard Street, Wigan) (Traffic Regulation) Order 1988.

The effect of this Order is to:

- (i) prohibit waiting at all times on the south-east side of Orchard Street, Wigan, from a point 2 metres south-west of Greenhough Street for a distance of 42 metres.
- (ii) reduce the existing prohibition of driving restriction in Orchard Street, Wigan, so that it will apply between Greenhough Street and a point 2 metres south-west of Greenhough Street.

Wigan Borough (Moor Road, Orrell, Wigan) (Prohibition of Waiting) Order 1988.

The effect of this Order is to prohibit waiting at all times on the east side of Moor Road, Orrell, Wigan, from the bridge over the M55 motorway to a point 93 yards north-east of Sefton Road.

Wigan Borough (Bradshaw Street, Orrell, Wigan) (Restriction of Waiting) Order 1988.

The effect of the Order is to restrict waiting between 8 a.m. to 6 p.m. Monday to Saturday on the west side of Bradshaw Street, Orrell, from a point opposite the northerly kerb-line of Queen Street for a distance of 20 metres in a southerly direction.

Copies of these Orders and the relevant maps may be inspected at the Civic Centre, Millgate, Wigan, between 9 a.m. and 4.30 p.m. on any day from Monday to Friday.

Any person who desires to question the validity of the Orders or any provisions contained therein on the ground:

- (i) that it is not within the powers of section 1 of the Road Traffic Regulation Act 1984, or
- (ii) that any requirement of the said section 1 or of Part III of Schedule 9 to the said Act or of any regulation made under the said Part III of Schedule 9, has not been complied with, may within 6 weeks of 13th February 1989 make application for the purpose to the High Court.
