The Croydon (College Road) Experimental Traffic Order 1989

Exemptions in the proposed Order will permit waiting for the purpose of picking up and setting down of passengers, loading and unloading of goods, maintenance of the roads and supply of statutory undertakers services and emergency services therein.

An exemption will also permit waiting by disabled persons' vehicles in accordance with the "orange badge" scheme.
