- (2) To authorise the council to: generally regulate the use of the parking place; suspend the use of the parking place or part thereof at any time; collect a charge for the use of the parking place (where appropriate); limit the maximum time which vehicles may wait in either parking or layover bays; stipulate the classes of vehicles which may use the parking place and the positions in which those vehicles may wait whilst in the parking place; make provisions as to the giving of information by a person keeping a vehicle or any other person in respect of a vehicle in the parking place and arrange for the removal and disposal of vehicles left in the parking place in certain circumstances where they are left in contravention of the Order.
- (3) To impose an excess charge of £20 for the offences set out below and to make regulations as to the payment of the charge.

Offences

Leaving a vehicle longer than the maximum permitted period in either a parking or layover bay; leaving a vehicle outside of either a marked layover or parking bay; leaving a vehicle in a parking bay other than that designated for the vehicle concerned; leaving a vehicle in the parking place for other than a permitted purpose; leaving a vehicle in other than the permitted position for that vehicle.

(4) To make provision whereby, if a sum of £15 is tendered within seven working days of an offence, as described in (3) above, being committed, such sum may be accepted in satisfaction of the Excess Charge.
