CHICHESTER DISTRICT COUNCIL

The District of Chichester (Off-street Parking Places) Order 1989

Notice is hereby given that the Council propose to make an Order under sections 39(1) and 124(1) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, the effect of which will be to amend the District Council of Chichester (Off-street Parking Places) Order 1981 in the following manner:

- to introduce charges made for the use of parking places at Northgate, New Park Road and the Cattle Market, Chichester (except for Wednesdays at the Cattle Market), North Street and Grange Road, Midhurst and Pound Street, Petworth, in accordance with the particulars described in Schedule 1 to this notice, such charges to be collected by means of pay and display machines;
- to vary the charges made for the use of parking places in Chichester in accordance with the particulars described in Schedule 2 to this notice;
- to issue conditional six-day roving season tickets for use at the parking places at Orchard Street, Avenue de Chartres (East and West), Basin Road, Northgate, New Park Road and the Cattle Market, Chichester, (except for Wednesdays at the Cattle Market) at a cost of £5 per month;
- to increase the cost of season tickets at the parking places at Market Road and Market Avenue (South Pallant), Chichester, from £104 to £130 per annum;
- to issue conditional 6 day season tickets for use of the parking places at Midhurst and Petworth at a cost of £3 per month;
- to vary the hours of charging at all parking places in the District to 8.30 a.m. to 5 p.m. from Monday to Friday and from 10 a.m. to 4 p.m. on Saturdays with the exception of the car parks at Little London and Baffins Lane, Chichester, where the hours of charging on Saturdays shall be from 8.30 a.m. to 5 p.m.

The remaining provisions of the 1981 Order will continue to be in force, with minor modifications, in the proposed new Order.

A copy of the draft Order, together with maps showing the location of the parking places and a statement of the Council's reasons for proposing to make the Order are available for inspection at East Pallant House, Chichester, and at the Area Offices at Midhurst and Petworth during normal office hours until Wednesday, 5th April 1989.

Objections to the proposals must be sent in writing to me stating the grounds of objection, on or before Wednesday, 5th April 1989.
