The proposals will provide for the issue of permits to residents of No's 1 to 11 (odd) and No. 2 Assembly Street; No's 2 to 14 (even) and 1 to 9 (odd) and No. 2 Assembly Street; No's 2 to 14 (even) and 1 to 9 (odd) Church Lane and No's 2 to 10 Garden Street for use on their own vehicles, with a visitor's permit per household, and business premises abutting the parking places will be able to obtain a parking permit at the discretion of the Council.
 - (b) To prohibit waiting by vehicles at any time in lengths of Railway Terrace, Lower Station Road and in the un-named road linking Railway Terrace and Lower Station Road.
 - (c) To impose one-way working for vehicles in the un-named road linking Railway Terrace and Talbot Street (south-west to north-east) (i.e., towards Talbot Street); Garden Street (southwest to north-east) (i.e., towards Cheapside); Market Place, west side, (south-east to north-west) (i.e., towards Lower Station Road) and in Market Place, north side (west to east) (i.e., towards Altofts Road).
 - (d) To prohibit driving by vehicles in a 14 metre length of West Street, starting at a point 18 metres south-east of the northwestern building line of No. 10 West Street and extending south-easterly.
