## OXFORD CITY COUNCIL

Notice of City of Oxford (Cowley Centre) (No. 1) Public Path Stopping-up Order 1989

Notice is hereby given that the above-named Order (hereinafter referred to as "the Order") made on 17th February 1989 is about to be submitted to the Secretary of State for the Environment or to be confirmed by the Oxford City Council as an opposed Order.

The effect of the Order, as confirmed without modification, will be to extinguish the public right of way as follows:

- (a) Pound Way from Crowell Road to The Square a distance of approximately 121.9 metres for its whole width varying from approximately 18.3 metres to approximately 13.4 metres.
- (b) An area of Pound Way to the north of and at the western end of the main mall being some 18.3 metres long and approximately 10.7 metres wide.
- (c) The steps leading from (b) above to Between Towns Road.
- (d) An area of Pound Way to the south of and at the western end of the main mall and connecting Pound Way with Hockmore Street measuring approximately 18·3 metres long and varying in width between 18·3 metres and 20·7 metres.
- (e) The whole of The Square measuring approximately 60-4 metres in length and varying in width between 34-4 metres and 30-5 metres.
- (f) An area leading from The Square to Between Towns Road being approximately 57.9 metres long and varying in width between 6.1 metres and 11.6 metres.
- (g) Upper Barr from The Square to Barns Road a distance of approximately 53 metres and varying in width from 5.2 metres to 10.7 metres.
- (h) An area leading from Upper Barr to Hockmore Street being some 18-2 metres long and varying in width from 7-9 metres to 3 metres.

A copy of the Order and the map contained in it has been deposited at the City Secretary and Solicitor's Department at St. Aldate's Chambers, St. Aldate's, Oxford, and may be inspected there, free of charge, between the hours of 10 a.m. and 4 p.m. on weekdays. Copies of the map and Order may be purchased.
