The Aylesbury Vale (Off-Street Parking Places) Order 1989

Notice is hereby given that on 8th March 1989, Aylesbury Vale District Council made the above-mentioned Order under section 35 and Schedule 9 of the Road Traffic Regulation Act 1984.

The notice of the proposal to make the above Order appeared in the *London Gazette* (issue No. 51619) dated 19th January 1989 under ref. 517. The effects of the Order, which relates to parking places in Aylesbury, are as described in that notice except for the following modifications:

- (a) the introduction of a 5½ hour charging period in all long term car parks at the rate of 90p;
- (b) the issue of long term season tickets at the concessionary rate of £75 to residential occupiers of the streets in Aylesbury listed in the Schedule to this notice.

BIRMINGHAM CITY COUNCIL

Birmingham City Council (Bordesley Green, etc., Bordesley) (Prohibition of Waiting) (Variation) Order 1989

Notice is hereby given, that on 17th March 1989, the above-named Council made the above-named Order under sections 1(1) and (2), 2(1) to (3), 4(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act the effect of which, is as follows:

- (1) To extend the existing "no waiting at any time" on three arms of the roundabout at the junction of Belchers Lane/Bordesley Green/Bordesley Green East.
- (2) To replace short lengths of "limited waiting" with "no waiting at any time" in the vicinity of two bus stops on Bordesley Green.
- (3) To introduce "no waiting at any time" in certain lengths of Broadway Avenue and Bordesley Green and Belchers Lane at their junction with Broadway Avenue.

The Order will come into operation on 21st March 1989.

A copy of the Order together with a map and a statement of the Council's reasons are available for inspection at the offices of the solicitor, Paradise Place, Birmingham B3 3EH, during normal working hours.

If any person wishes to question the validity of the Order or any of the provisions contained in it on the grounds that it is not within the powers conferred by the Act or on the grounds that any requirements of the Act or any Instrument made under it has not
