The Secretary of State for Transport hereby gives notice that he has made an Order under section 209 of the above Act entitled "The Stopping-up and Diversion of Highways (London Borough of Barnet) (No. 1) Order 1989" authorising the stopping-up of the redundant traffic lane in the northbound carriageway of Watford Way (Barnet By-pass) which starts 470 metres north-west of Hall Lane and part of the footway of Watford Way and requiring the diversion of the footpath between Watford Way and the footbridge over the M1 Motorway.
