(b) for the Wellington Road (north) and the Wellington Road (south) Car Parks the charges are increased from 10p per 2 hours to 10 pence per 1 hour.

The Order also increases the standard charge payable, if no parking ticket is purchased, on the Pine Street Car Park in Huddersfield to £12 in line with all the other car parks in Kirklees which were amended in this respect in May 1988.

The Order also incorporates a number of amendments made under previous Orders which will then be revoked.
