Designation of the Wigston (Spa Lane) Conservation Area

Notice is hereby given, pursuant to section 277 of the Town and Country Planning Act 1971, as amended, that the Oadby and Wigston Borough Council, being the Local Planning Authority for the subject area, has designated the Wigston (Spa Lane) Conservation Area, the character of which is desirable to preserve or enhance.

Notice is also hereby given to owners and occupiers of the properties within the designated Conservation Area of the effect of the designation. The effect is to impose further controls on development in the area as follows:

-) The prior approval of the planning authority may be required for the demolition of a building or part of a building within conservation areas.
- (ii) Applications for planning permission which, in the opinion of the local planning authority, affect the character or appearance of the conservation area must be formally advertised in accordance with section 28 of the Town and Country Planning Act 1971.
- (iii) Certain trees within the conservation area cannot be felled, topped, lopped or uprooted unless 6 weeks prior notification has been given to the local planning authority and it is an offence not to give such notice. It is also an offence to wilfully damage or destroy a tree in a conservation area.
- (iv) Advertisements in conservation areas may also be controlled by the local planning authority to avoid detraction from the appearance of the conservation area.

Plans of the Conservation Area may be seen at the Council Offices, Station Road, Wigston, Leicester at any time during normal office hours.

The Area which has been designated is as follows:

That land bounded by: so much of the eastern edge of the carriageway of Bull Head Street that is situate to the front of Nos. 22-80 (inclusive) Bull Head Street; the southern and western boundary of 80 Bull Head Street; the northern boundary of the car park serving 82 Bull Head Street; the north-eastern boundary of 2 and 4 Kelmarsh Avenue; the western boundary of 3 Shearsby Close; across Shearsby Close; the south-eastern and eastern boundaries of 19 Spa Lane; across Spa Lane; the eastern and northern boundaries of 20 Spa Lane the latter extending westward to the eastern boundary of 20 Bull Head Street; the northern boundary of Bull Head Street.
