Devon County Council (Heanton Street, Braunton) (Prohibition of Driving) Order 1989

Notice is hereby given that, on 23rd March 1989, the Devon County Council made the above-named Order under sections 1 and 2 of the Road Traffic Regulation Act 1984 the effect of which is as detailed in the *London Gazette* issue no. 51641, dated 9th February 1989 under reference 501.

DONCASTER BOROUGH COUNCIL

Doncaster Borough Council (Various Roads, Adwick upon Dearne and Mexborough) (Traffic Regulation Consolidation) Order 1986 (Amendment No. 2) Order 1988.

Notice is hereby given that on 20th March 1989 the Doncaster Borough Council made an Order under the provisions of the Road Traffic Regulation Act 1984.

The effect of the Order which will come into operation on 10th April 1989 will be to prohibit the waiting of any vehicle on the eastern side of Station Road, Mexborough, from its junction with the Mexborough Relief Road for a distance of 160 metres in a southerly direction and on the western side of Station Road from its junction with the Mexborough Relief Road for a distance of 22 metres in a southerly direction.

Exceptions to the Order will permit waiting for the purpose of picking up and setting down passengers, loading and unloading goods, in connection with building, industrial or demolition operations, the removal of obstructions to traffic, the maintenance of the roads and the services therein, in pursuance of statutory powers or duties and for the collection and delivery of postal packets. The usual exceptions for disabled persons' vehicles are also included in the Order.

The South Yorkshire County Council (Various Roads Doncaster) (Traffic Regulation Consolidation) Order 1986 (Doncaster Borough Council) (Amendment No. 18) Order 1988.

Notice is hereby given that on 20th March 1989, the Doncaster Borough Council made an Order under the provisions of the Road Traffic Regulation Act 1984.

The effect of the Order which will come into operation on 10th April 1989, will be to:

- (a) Prohibit the waiting by vehicles at any time along that length of College Road, Doncaster as specified in Part I of the Schedule to this notice.
