

- or apparatus for the supply of gas, water or electricity or of any telecommunication system thereunder or thereon, or the placing, maintenance or removal of any traffic sign thereon; or
- (d) to anything done with the permission or at the direction of a police constable in uniform; or
- (e) in respect of anything done in accordance with any restriction or requirement indicated by traffic signs placed on the highway by or on behalf of the Metropolitan Police.

A copy of the Order, which will come into operation on 5th April 1989, can be inspected during normal office hours on Mondays to Fridays inclusive, until the end of a period of 6 weeks from the date on which the Order was made, in Room 317, Guildhall 2, Kingston upon Thames, KT1 1EU.

(ii) On the southerly side from a point 71 metres west of the westerly boundary of Northumberland Street for a distance of 11 metres in a westerly direction.

(iii) On the south-easterly side from a point 276 metres west of the westerly boundary of Northumberland Street for a distance of 38.5 metres in a south-westerly direction.
