ROAD TRAFFIC REGULATION ACT 1984

The North Devon Link Road (Stage 2A) (24-Hour Main Carriageway Clearway) Order 1989

(b) to a vehicle waiting whilst any gate to premises visited is opened or closed, a vehicle waiting on the direction or with the permission of a police constable or traffic warden, a vehicle obliged to stop to avoid an accident or a vehicle prevented from proceeding by circumstances outside his control.

The Order also prohibits any vehicle from waiting on any part of the said length of trunk road for the purpose of selling or dispensing goods from or in that vehicle, unless the goods are immediately delivered at, or taken into, premises adjacent to the land on which the vehicle stood at the time when goods were sold or dispensed.
