Proposed Traffic Regulation Orders at Braintree

Notice is hereby given that the Essex County Council proposes to make the following traffic regulation Orders at Braintree in the District of Braintree under sections 1, 2, 3 and 4 of the Road Traffic Regulation Act 1984, following the opening to traffic of the Braintree By-pass.

(1) Essex County Council (Various Streets, Braintree) (One-way Traffic) Order 1989

The effect of the Order will be to impose, vary and revoke one way working at Braintree as follows:

(a) To re-introduce two-way working on the following lengths of road at Braintree by the revocation of the existing one-way traffic regulation Order:

Rayne Road, from its junction with Pierrefitte Way/Aetheric Road for a distance of 275 metres to its junction with Panfield Lane.

(However that length of Rayne Road which extends from its junction with Panfield Lane eastwards to its junction with Bocking End will remain subject to one-way working in an easterly direction)

Coggeshall Road, from a point 55 metres east of its junction with Bank Street for a distance of 436 metres to its junction with Railway Street/Courtauld Road.

Railway Street, for its entire length ie. from its junction with Coggeshall Road/Courtauld Road to its junction with South Street/Rose Hill/Station Approach.

Victoria Street, from its junction with Fairfield Road eastwards for a distance of 108 metres to a point in line with the eastern boundary of the bus station.

Fairfield Road, from its junction with Manor Street southwards for a distance of 83 metres to its junction with Victoria Street.

(However that length of Fairfield Road which extends from its junction with South Street northwards to its junction with Victoria Street will remain subject to one way working in a northerly direction)

Grenville Road, for its entire length ie. from its juction with Clare Road northwards for a distance of 230 metres.

Clare Road, from its juction with London Road (the newly constructed Pierrefitte Way) to its junction with Grenville Road.

(b) To formally revoke the existing one-way traffic regulation Order on the following length of road at Braintree:

Sandpit Road, from a point 5 metres north of its junction with High Street to a point 46 metres north of that junction.

(c) To vary the existing one-way traffic working by reversing the flow of traffic in the following lengths of road at Braintree.

Manor Street, from its junction with Railway Street westwards for a distance of 69 metres to its junction with Mount Road, in an east to west direction.

Victoria Street, from a point 108 metres east of its junction with Fairfield Road eastwards for a distance of 266 metres to its junction with Railway Street, in a west to east direction.

(d) To impose one-way traffic working on the following lengths of road at Braintree:

Bocking End, from its junction with Rayne Road northeastwards for a distance of 49 metres to its junction with the access road to the Institute Hall, in a south to north direction.

B1018 Cressing Road, (north-west bound carriageway only) a point 15 metres south-east of its junction with the A120 Coggeshall Road, in a north-west to south-east direction.

Also the new Order will consolidate all those roads already subject to one way working and not mentioned above, so that the following Orders and parts of Orders will be revoked:
