ROAD TRAFFIC REGULATION ACT 1984

The A12 Trunk Road (Martlesham By-pass) (Woodbridge Roundabout) (De-restriction) Order 198

The Secretary of State for Transport hereby gives notice that he has made an Order under sections 82(2) and 83(1) of the Road Traffic Regulation Act 1984, the effect of the Order which comes into operation on 22nd May 1989, will be that the length of road specified in Schedule 1 to this notice shall cease to be a restricted road for the purposes of section 81 of the Road Traffic Regulation Act 1984.

PETROLEUM AND SUBMARINE PIPE-LINES ACT 1975

Notice of the Issue of a Submarine Pipe-Line Works Authorisation

The Secretary of State for Energy hereby gives notice that he has decided to issue, and in consequence has issued, a works authorisation to Marathon Oil U.K., Ltd., whose address is Marathon House, 174 Marylebone Road, London NW1 5AT, for the construction of a 10-inch pipe-line, a 4-inch pipe-line, a 6-inch pipe-line and a 5-inch umbilical between the Central Brae subsea template and the Brae 'A' platform.

Except with the consent of the Secretary of State, the 10-inch pipe-line shall only be used to convey water, the 4-inch pipe-line shall only be used to convey inhibitors and well fluids, the 6-inch pipe-line shall only be used to convey crude oil and the 5-inch umbilical shall only be used to convey chemicals.
