## COAST PROTECTION ACT

### WAVENEY DISTRICT COUNCIL

#### COAST PROTECTION ACT 1949, SECTION 5

#### *Works at Ness Point, Lowestoft, Suffolk*

Notice is hereby given that Waveney District Council, acting as Coast Protection Authority for the coastline incorporating Ness Point, Lowestoft, hereby gives notice of its intention to carry out Coast Protection works to reconstruct and improve the sea walls immediately to the north and south, known as Silver Rail and Hamilton Sea Walls respectively.

These structures are located at the most exposed point of the North Lowestoft defence system which protects the low-lying Denes area, including valuable industrial development from erosion and flooding by the sea.

Throughout their lives these sea walls have been the subject of major reconstruction and repair schemes reflecting the continuing trend of scour at this exposed site.

It is intended to phase the repairs over 3 years. The initial phase will be to re-pile the Silver Rail frontage (following the recent collapse of the present toe piles) reconstruct a principal groyne andrevet another both with concrete units, to provide stability and to absorb wave energy.

Subsequent phases will provide a similar revetment in front of the Silver Rail piles and improve that in front of the Hamilton Sea Wall.

Phase 1 is programmed to start in September 1989, and the whole scheme estimate is £2.1 million.
