**SOUTH SOMERSET DISTRICT COUNCIL**

*The District of South Somerset (Hermitage Road and Limepits Lane at Upton, Long Sutton) Weight Restriction Order 1989*

Notice is hereby given that the South Somerset District Council, as agents for the Somerset County Council, on 13th June 1989, made the above Order under sections 1(1) and (2), 2(4) and 3(2) of the Road Traffic Regulation Act 1984, the effect of which is the prohibition of vehicles in excess of 7.5 tonnes maximum gross weight in proceeding in lengths of Hermitage Road and Limepits Lane at Upton, Long Sutton with the exception of vehicles loading and unloading at premises adjoining these lengths, for the maintenance of the roads and for emergency service vehicles. The Order becomes operative from 15th June 1989.

The Order makes permanent the temporary weight restriction which came into operation on 5th December 1988.
