### WELSH OFFICE

The Secretary of State for Wales hereby gives notice that he proposes on the application of the Monmouth Borough Council, to make an Order under section 212 of the Town and Country Planning Act 1971 extinguishing, subject to some exceptions, any rights which persons may have to use vehicles on the length of highway described in the Schedule to this notice.

During 28 days from 20th July 1989 copies of the draft Order and relevant plan may be inspected free of charge at all reasonable hours at the Offices of Monmouth Borough Council, New Cash Office, Woodstock Way, Caldicot; and Monmouth Borough Council, Mamhilad House, Mamhilad Park Estate, Pontypool.

Within the above-mentioned period of 28 days any person may by notice to the Welsh Office, Highways Directorate, Roads Administration Division, Government Buildings, Ty Glas Road, Llanishen, Cardiff CF4 5PL (quoting ref. WR15/3/401), object to the making of the Order, stating the grounds for objection. In the preparation of an objection and the statement of grounds of objection, it should be borne in mind that the substance of any objection or representation may be communicated to other people who may be affected by it.

#### TOWN AND COUNTRY PLANNING ACT 1971

##### *Proposed stopping up of part of a highway at Bolton*
