GREAT GRIMSBY BOROUGH COUNCIL

The Borough of Great Grimsby (Various Streets) (Traffic Regulation) (No. 45) Order 1989

(e) *Columbia Road*, on both sides, from a point 14 metres east of the eastern kerb-line of Ladysmith Road to a point 24 metres east of the eastern kerb-line of Ladysmith Road.

- (2) To impose restrictions for no waiting 8 a.m. to 6 p.m., Monday to Saturday, in:

(a) *Ainslie Street*, on the east side, from a point 15 metres south of the southern kerb-line of Lambert Road to a point 45 metres north of the northern kerb-line of Welholme Road, and on the west side from a point 15 metres south of the southern kerb-line of Abbey Drive East to a point 15 metres north of the northern kerb-line of Lambert Road.

(b) *Littlefield Lane*, on the south-east side, from a point 14 metres south-west of the south-western kerb-line of Chantry Lane to a point 120 metres north-east of the north-eastern kerb-line of Dudley Street.

- (3) To revoke some existing restrictions for no waiting 8 a.m. to 6 p.m., Monday to Saturday, in parts of Abbey Drive East, Ainslie Street, and Granville Street.

- (4) To impose restrictions to make part of Legsby Avenue a one-way street, namely the section from a point 28 metres south of the southern kerb-line of Welholme Road, to the northern kerb-line of Patrick Street, in the direction north to south.

- (5) To revoke Article 17 of the County of Humberside (Great Grimsby Borough Council) (Grimsby Traffic Regulation) Order 1976 (which makes provision for parking by hackney carriages only to wait in parts of Old Market Place) and to revoke the whole of the County of Humberside (Great Grimsby Borough Council) (Grimsby Traffic Regulation) (Amendment) Order 1982 (which makes similar provision for parts of Garibaldi Street).
