

Should it appear to the Secretary of State that the Order is required to be made urgently if it is to enable the Authority effectively to meet the deficiency of supplies of water referred to above, he may direct that the holding of a public inquiry or a hearing by a person appointed by him should be dispensed with.

RYEDALE DISTRICT COUNCIL

CLEAN AIR ACT 1956

Haxby and Wigginton (No. 5) Smoke Control Order 1989

Notice is hereby given that the District Council of Ryedale, in exercise of the powers conferred on them by section 11 of the above-mentioned Act, as amended by section 1 and Schedule 2 of the Local Government, Planning and Land Act 1980, proposed on 18th May 1989 to make an Order entitled *Haxby and Wigginton (No. 5) Smoke Control Order 1989*, declaring the area described in the Schedule hereto to be made a smoke control area.

Subject to the exemptions provided by the Order and by virtue of section 11(4) of the Clean Air Act 1956, if, on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the smoke control Order area, the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £400 unless he proves that the emission of smoke was not caused by the use of any other fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

Subject to the provisions of section 9 of the Clean Air Act 1968, any person who acquires for use in a Smoke Control Area any solid fuel other than an authorised fuel shall be guilty of an offence and liable to a fine not exceeding £400.

If made, the Order will come into operation on 1st September 1990, or at a later date determined by Ryedale District Council.

Copies of the draft Order and the map referred to therein may be inspected free of charge at Ryedale House, Malton and the Council's Area Office, 56 Bootham, York, at all reasonable times during the period of 6 weeks from 13th July 1989.

Within the said period any person who will be affected by the Order may, by notice in writing to D. Cudworth, Chief Executive, Ryedale District Council, Ryedale House, Malton, North Yorkshire YO17 0HH, object to the making of the Order.

SOUTH WEST WATER

CONTROL OF POLLUTION ACT 1974

Notice of Application for Consent under section 34

Notice is hereby given, pursuant to section 36(1)(a) of the Control of Pollution Act 1974 that, an application has been made to the South West Water Authority by West Devon District Council, to discharge fully treated domestic sewage effluent to the River Tavy at National Grid Reference SX 4972 7600 from Pitts Cleave Quarry, Tavistock.

The maximum rate of discharge shall not exceed 0.87 cubic metres in any one hour, or 5.25 cubic metres in any period of 24 hours.

The effluent quality conditions proposed by South West Water include 20 mg/l BOD, 30 mg/l suspended solids, pH 6-9.

Compliance with the above conditions will maintain the watercourse within its quality class and as such the discharge will have no deleterious downstream effect.
