### PRIVY COUNCIL OFFICE

#### UNIVERSITIES OF OXFORD AND CAMBRIDGE ACT 1923

A Statute made by the Governing Body of Queens' College, in the University of Cambridge, on 30th June 1989, amending Statutes 6, 9, 12, 14, 19 and 30, has been submitted for the approval of Her Majesty in Council, and notice of its having been submitted is published in accordance with the provisions of the Universities of Oxford and Cambridge Act 1923.

The purpose of the amendment is to permit the election of women as President of the College; to alter the rules regarding the tenure and retirement of the President; to allow a Bye-Fellow to hold office for up to 12 years; to remove the reference to the payment of residence money; to bring pensions regulations into line with national legislation; and to remove the present requirement of Pernoctation.

#### ROAD TRAFFIC

#### *The A63 Trunk Road (Welton) (Prohibition of U-Turns) Order 1989*

The Secretary of State for Transport hereby gives notice that on 17th July 1989 he made an Order under Sections 1(1) and (2) and 2(1) and (2) of the Road Traffic Regulation Act 1984 which comes into operation on 21st July 1989.

The effect of the Order is as described in issue number 51662 of *The London Gazette* dated 3rd March 1989 (ref T2586).

Any person who desires to question the validity of, or any provision contained in the Order, on the ground that it is not within the powers with respect of the Order, conferred by the above Act, or on the ground that any requirement of, or of any instrument made under, any provision of that Act has not been complied with in relation to the Order may, within 6 weeks of 19th July 1989 apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

#### TOWN AND COUNTRY PLANNING ACT 1971

#### *Stopping Up of a Highway at Failsworth*

The Secretary of State for Transport hereby gives notice that on the application of Oldham Metropolitan Borough Council, on behalf of Mr M. White, he has made an Order under S209 of the above Act entitled "The Stopping up of Highways (Metropolitan Borough of Oldham) (No 5) Order 1989" authorising the stopping up of an unnamed passageway adjacent to 20 Frank Street, Failsworth.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the above Act or that any requirement of that Act or of any regulation made thereunder has not been complied with in relation to the Order, may, within 6 weeks of the 19 July 1989 apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
