TREASURY

RATES OF INTEREST ON LOANS BY THE PUBLIC WORKS LOAN COMMISSIONERS TO LOCAL AUTHORITIES

NOTICE

TREASURY MINUTE dated 30th August 1989.

The Lords Commissioners of Her Majesty's Treasury read section 3(2) of the National Loans Act 1968 (1968 c.13 as amended) whereby any sums borrowed from the Public Works Loan Commissioners shall bear interest at such rates as the Treasury may determine from time to time in accordance with section 5 of the said Act.

My Lords understand that the Public Works Loan Commissioners will be operating arrangements under which local authorities are permitted to borrow from the Commissioners up to a specified quota at a certain fixed rate of interest and in excess of such quota at one of two higher fixed rates.

In accordance therewith the Chancellor of the Exchequer now recommends that with effect from 31st August 1989 and until the coming into operation of a further determination:

- (i) The rate of interest applicable to any such fixed rate loan will be that in force on the day the authority applies to borrow or, if the application is before noon three working days before the loan is credited to the account of the authority's banker, the rate in force at 11 a.m. two banking days before credit day;
- (ii) Different rates of interest shall be charged on such fixed rate loans according to whether the principal of a loan is repaid by instalments or at maturity and, if repaid by instalments, whether by equal instalments of the principal with interest paid on the decreasing balance of the principal (E.I.P.), or by instalments of equal repayments of the principal and interest paid thereon (E.R.);
- (iii) The rates of such interest shall be:

The amount which a local authority borrows within its annual quota will bear interest at the appropriate rate in the quota set of rates. Authorities may borrow further sums at quota rates at the discretion of the Public Works Loan Commissioners. Other borrowing beyond the quota entitlement will be at the appropriate rate in the non-quota set of rates.

My Lords concur.

COAST PROTECTION ACT 1949

Work to protection of eroding cliffs at Crewe Street

The Berwick-upon-Tweed Borough Council acting in their capacity as Coast Protection Authority hereby give notice under the above Act that they propose to carry out coastal protection works as described herein at North Sunderland Harbour, Seahouses, Northumberland.

The work will consist of approximately 180 metres of combined wave wall and earth retaining wall constructed in reinforced concrete on the foreshore to protect an existing embankment. The new wall will terminate into existing rock cliff at the east end and terminate into the existing sloped embankment at the west end. A new embankment to revised slopes will be formed landward of the new wall and incorporate swash protection blockwork and landscaping. Existing masonry walls supporting the Crewe Street embankment will be buried or removed. The general level of the top of the new wall is to be +5.2 metres AOD. The estimated total cost of the works is £300,000.

Any person may, not later than 30th September 1989, serve a written notice of objection to the above proposal on the Minister of Agriculture, Fisheries and Food and on the above mentioned Authority.
