*Notice published by the Director General of Telecommunications under section 12 of the Telecommunications Act 1984*

Proposed modifications of the Conditions of the Licences granted to Racal-Vodafone Limited (Racal) and Telecom Securicor Cellular Radio Limited (Cellnet) to run telecommunications systems.

1. The Director General of Telecommunications (the Director) hereby gives notice that he proposes under section 12 of the Telecommunications Act 1984 ("the Act") to modify the Conditions in the Licences granted to Racal and Cellnet by amending the Conditions to those Licences.

2. The effect of the modifications is:

(a) to amend the definition of "Relevant Connectable System" in Part I of Schedule 1 to the Licences to confer on the Director a power to determine that telecommunications systems are not to be treated as Relevant Connectable Systems where they otherwise are within the scope of the definition;

(b) to amend the provision made in Condition 13 for the situation when the contract of a service provider, reselling to the public telecommunications services provided by Racal and Cellnet, is broken or the service provider is otherwise unable to provide its customers with service, by enabling that service to be more easily provided directly by Racal and Cellnet for a short period while arrangements are made for a service provider to resume the provision of the service in the normal way;

(c) to amend the arrangements set out in Condition 34 under which Racal and Cellnet pay fees to the Secretary of State in order to place them on the same footing in regard to the payment of fees as the fixed link public telecommunications operators; British Telecommunications Plc, Mercury Communications Limited and Kingston-upon-Hull City Council and Kingston Communications (Hull) Plc ("the fixed link PTOs"); and

(d) to amend the provision in Condition 39 relating to trial services to permit it to operate in respect of services provided to a limited class of customers as well as provided in a limited area.

3. The reasons for the proposed modifications are:

(a) in the case of the modification described at 2(a) and (d) to put the regulatory powers of the Director in relation to Racal and Cellnet in respect of the interconnection of networks and trial services on the same basis as they operate in relation to the fixed link PTOs;

(b) in the case of the modification described in 2(b) to improve the quality of telecommunication services provided to customers, purchasers and other users in the United Kingdom by making better provision for the circumstances described; and

(c) in the case of the modification described at 2(c) to make more equitable provision for apportioning the costs of regulation under the Act between Racal and Cellnet, the fixed link PTOs and other licensees.

4. The Director is required by section 12(2) of the Act to consider any representations or objections which are duly made and not withdrawn in respect of the modifications.

5. Any persons whose interests are likely to be affected by the modifications, and who wish to make representations in respect of any or all of them should do so in writing to Mrs. J.
