WIRELESS TELEGRAPHY ACT 1949

Notice of Variation

The Secretary of State gives notice pursuant to sub-section 1(4) of the Wireless Telegraphy Act 1949 to all those who are licensed under the maritime Radar Beacon, Radar (Land) Station and Radio Beacon Licenses which have been issued and remain in force, that from 1 November 1989 each of such licenses shall be varied so as to read as follows:

This licence (the "Licence") granted under section 1 of the Wireless Telegraphy Act 1949 (the "Act") on (the "Date of Issue") by the Secretary of State for Trade and Industry (the "Secretary of State") to (the "Licensee") authorises the Licensee to instal and use the apparatus for wireless telegraphy described in clause 1 subject to the terms and limitations contained in the licence.

The Licensed Apparatus

 The Licensee may intal and use the apparatus specified in column 1 of the Schedule to this Licence (the "Apparatus") at the locations specified in column 2 of the Schedule.

Terms and Limitations of Use

- The Licensee shall use the Appartus only for the purpose of aiding the navigation of any ship or aircraft and only:
 - (a) to send, receive or re-transmit a mesage or signal by nonautomatic means; or
 - (b) to send, receive or re-transmit a message or signal by automatic means in order to indicate:
 - (i) to any ship or aircraft its position in relation to any Apparatus, or
 - (ii) to any of the Apparatus the positon or absence of any object of any description.
- 3. The Licensee shall use the Apparatus at or with:
 - (a) the call sign or identification signal (if any) specified in column 3 of the Schedule; maximum
 - (b) the frequency and maximum frequency tolerance in column 4 of the Schedule;
 - (c) the emission designation specified in column 5 of the Schedule;
 - (d) the pulse characteristics specified in column 6 of the Schedule;
 - (e) a power not exceeding, whichever is the greater of, those specified in column 7 of the Schedule; and
 - (f) the antenna characteristics specified in column 8 of the Schedule.

Apparatus

4. The Licensee shall ensure that, notwithstanding any other term of this Licence, the Apparatus is designed and constructed, and maintained and used, so that its use does not cause any undue interference.

Users of Apparatus

- 5.(1) The Licensee shall not permit or suffer any person to use the Apparatus unless the person is:
 - a) under the control of the Licensee; and

 - (b) authorised by the Licensee to use the Apparatus.

 (2) The Licensee shall ensure that all person using the Apparatus are made aware of and comply with the terms of the Licence.

Other Requirements

6. The Licensee shall comply with:
