BATH CITY COUNCIL

The Bath City Council (No. 7) Smoke Control Order 1990

Notice is hereby given that the Bath City Council in exercise of the powers conferred upon them by Section 11 of the Clean Air Act 1956 propose to make an Order entitled the Bath City Council (No. 7) Smoke Control Order 1990 declaring the area described in the Schedule hereto to be a Smoke Control Area.

Subject to the exemptions provided by the Order and by virtue of Section 11(4) of the Act if, on any day after the Order has come into operation, smoke is emitted from a chimney or any building within the Smoke Control Area the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £400 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, electricity and gas.

It is proposed that the Order shall come into operation on 1st October 1990.
