The Stopping Up of Highways (Corner of Union Street and Barrack Lane, Cardiff) Order 1990

The Secretary of State for Wales hereby gives notice that he has made the above Order under section 209 of the Town and Country Planning Act 1971, to authorise the stopping up of the highway described in the Schedule to this notice to enable development to be carried out.

Copies of the Order may be inspected free of charge at all reasonable hours at the offices of the City Planning and Development Office, Cardiff City Council, Wood Street, Cardiff.

If any person desires to question the validity of the Order, or of any provision contained therein, on the grounds:

(a) that it is not within the powers of the Town and Country Planning Act 1971; or

(b) that his interests have been substantially prejudiced by a failure to comply with any of the requirements of that Act.

he may within 6 weeks of 20th February 1990, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

The area of highway to be stopped up is at Cardiff in the County of South Glamorgan. It is shown as an edged black circle on the deposited plan and consists of a circular area of land on the corner of Union Street and Barrack Lane, 1,100 millimetres in diameter.
