On Moody's Hill the boundary includes the curtilage of No. 20 and turns north to the railway west of the tennis courts but excluding 1-6 Moody's Hill curtilages and most of their access road. Following the railway, the boundary turns north to follow the river, west to include the curtilage of No. 27 and 28, then along fences to follow the garden wall of Church Farm then the rear boundary of Tanglewood to turn east along the north boundary of the Borbach Chantry former graveyard. The boundary there includes the ancient monument and the copse before heading east to Rectory Hill. It follows the county boundary south, to OS parcel 7082 where the boundary heads west along a field boundary around the curtilage of Whitegates and back to Moody's Hill. (723)
