(Prohibition of Waiting) Order 1990*

Notice is hereby given that the Wigan Borough Council, in exercise of the powers under section 1 of the Road Traffic Regulation Act 1984, proposes to make the Wigan Borough (Church Street/Cottesmore Way, Golborne) (Prohibition of Waiting) Order 1990.

The effect of the Order will be to introduce a restriction of waiting at all times as follows:

- (i) Church Street, Golborne (East Side) from a point 15 metres south of Cottesmore Way to a point 15 metres north of Cottesmore Way.
- (ii) Cottesmore Way, Golborne (both Sides) from Church Street for a distance of 15 metres.

There will be limited exceptions permitting vehicles to wait—

- (a) to enable people to board or alight;
- (b) for the purpose of building and similar operations, removing obstructions to traffic, road works and works by statutory undertakers;
- (c) for local authority, North West Water Limited and Post Office purposes;
- (d) if the vehicles are fire service or police vehicles or ambulances;
- (e) to take on fuel, water or air at any garage; or
- (f) for the delivery or collection of goods and for loading or unloading.

A copy of the proposed Order, and of the relevant map, and of a statement of the reasons for proposing to make the Order, and of the Orders to be revoked, may be inspected at the Civic Centre, Millgate, Wigan between 9 a.m. and 4.30 p.m. on any day from Monday to Friday.

Waiting) Order 1990*

Notice is hereby given that the Wigan Borough Council, in exercise of the powers under section 1 of the Road Traffic Regulation Act 1984, proposes to make the Wigan Borough (Eccles Road, Kitt Green, Wigan) (Prohibition of Waiting) Order 1990.

The effect of the Order will be to introduce a prohibition of waiting at all times on the south side of Eccles Road, Kitt Green from a point 15 metres west of City Road for a distance of 30 metres in a westerly direction.

There will be limited exceptions permitting vehicles to wait—

- (a) to enable people to board or alight;
- (b) for the purpose of building and similar operations, removing obstructions to traffic, road works and works by statutory undertakers;
- (c) for local authority, North West Water Limited and Post Office purposes;
- (d) if the vehicles are fire service or police vehicles or ambulances;
- (e) to take on fuel, water or air at any garage; or
- (f) for the delivery or collection of goods and for loading or unloading.

- (e) to take on fuel, water or air at any garage; or
- (f) for the delivery or collection of goods and for loading or unloading.
