#### TOWN AND COUNTRY PLANNING ACT 1971

*The Stopping-up of Highway (Rear of 145-157 Cowbridge Road East, Cardiff, South Glamorgan) Order 199*

The Secretary of State for Wales hereby gives notice that he proposes to make an Order under section 209 of the Town and Country Planning Act 1971 to authorise the stopping-up of the highway described in the Schedule to this notice to enable development of boundary walls and gates, for which planning permission has been granted, to be carried out.

During the 28 days from 9th April 1990, copies of the draft Order and the relevant plan may be inspected free of charge at all reasonable hours at the offices of Cardiff City Council, City Planning and Development Offices, Wood Street, Cardiff.

The highway to be stopped up is at Cardiff in the County of South Glamorgan. It is shown by zebra hatching on the deposited plan and is the length of highway to the rear of Nos. 145-157 Cowbridge Road East, which extends from No. 157 in an easterly direction for a distance of 47 metres. (15 SI)
