Derby City Council (Caesar Street) (Amendment to Waiting Restrictions) Order 1990

Notice is hereby given that Derby City Council, pursuant to an arrangement made under section 101 of the Local Government Act 1972 with Derbyshire County Council in exercise of the powers of the said County Council, under sections 1(1) and (2), 2(1) to (3), 4(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, made an Order on 27th March 1990, the effect of which is from 29th March 1990 the Derby City Council (Caesar Street) (Waiting Restrictions) Order 1987 will be amended to prohibit waiting in the following lengths of Caesar Street between the hours of 9 a.m. and 5 p.m. Mondays to Fridays:

(a) North side: from a point 15 metres west of its junction with Mansfield Road for a distance of 53 metres.

(b) South side: from a point 55 metres east of its junction with Mansfield Road for a distance of 10 metres.

The County of Derby (Wilsthorpe Road, Long Eaton) (Traffic Regulation) Order 1990

Notice is hereby given that the Derbyshire County Council propose to make an Order under sections 1(1) and (2), 2(1) to (3) of the Road Traffic Regulation Act 1984, and all other enabling powers and after consultation with the chief officer of police the effect of which will be:

No person (other than those requiring access to premises or land adjacent to the length of road) shall cause any vehicle to proceed in the length of road known as Wilsthorpe Road (west) service road—fronting house numbers 127-151 Wilsthorpe Road (inclusive).

No person shall cause or permit any motor vehicle to be driven on the Wilsthorpe Road (west) service road in a northerly or southerly direction at a point adjacent to the southern boundary of number 127 Wilsthorpe Road.

DERBYSHIRE COUNTY COUNCIL

The County of Derby (Edward Street, Glossop) (Prohibition of Waiting) Order 1990

Notice is hereby given that the Derbyshire County Council propose to make an Order under sections 1, (1) and (2), 2(1) to (3) and 4(2) of the Road Traffic Regulation Act 1984 and of all other enabling powers.

When this Order comes into effect you will not be allowed to leave your vehicle in the following lengths of road at Glossop. Waiting prohibited at anytime Edward Street, on the south side from its junction with Arundel Street to its junction with Bernard Street.

Exemptions will be provided in the Order to enable vehicles to wait for so long as may be necessary for a person to board or alight from the vehicle; to enable goods to be loaded onto or unloaded from the vehicle; to enable the vehicle to be used in connection with any
