Maidstone Borough Council (Mote Park, Maidstone) (Prohibition of Vehicular Access, 12 m.p.h. Speed Limit and One-way Traffic) Experimental Order 1990

Notice is hereby given that on 11th April 1990, the Maidstone Borough Council, pursuant to arrangements made under section 101 of the Local Government Act 1972, with the Kent County Council in exercise of their powers under section 9 and Schedule 9 of the Road Traffic Regulation Act 1984, made an Experimental Traffic Regulation Order.

From 22nd April 1990, the effect of the Order will be to prohibit access and movement of motor vehicles (including motor bikes and motor cycles) within the boundaries of Mote Park, Maidstone between the hours of 10 p.m. and 6 a.m. Vehicles being used for police, fire brigage or civil defence purposes or by statutory undertakers or a local authority in pursuance of their duties, or an ambulance being driven in a case of emergency, will be exempt from this prohibition of access.

The Order also encompasses the following existing restrictions operating within Mote Park:

- (a) All vehicular traffic shall be prohibited from travelling at any speed greater than 12 m.p.h. within the boundaries of the park;
- (b) One-way traffic operating only in the direction from the Mote Avenue entrance to the park in an easterly direction for a distance of 300 metres, then in a southerly direction for a distance of 70 metres, and then in a south-westerly direction for a distance of 60 metres, and then in a north-westerly direction for a distance of 300 metres to the Mote Avenue exit.

The access road to Mote Park Swimming Pool will be excluded from the above restrictions. All visitors and patrons of events at Mote Park Pavilion, the Sailing Club and Model Engineering Club will be granted exemption from the vehicular access restrictions for the duration of any event.

The following parties will also be granted an exemption from the provisions of the Order relating to the vehicular access, and access for these parties will be by means of a permit to be issued by the Borough Council:

Residents and Staff of:

Mote House (Cheshire Home), 1 to 3 Forge Lodge Bungalows, Garden Lodge, The Old Bothy, Mote Gardens, 1 and 2 Keepers Cottages, Mote Lodge, 1 and 2 Forge Lodge, Mote Cottage, 1 to 3 Mote Bungalows, Church Lodge, 1 and 2 Mansion Cottages, Raigersfeld House, Raigersfeld Lodge, New Lodge.

This Experimental Order will continue in force for 9 months, during which time it effects will be monitored in consultation with the police. After this period, the Council will then consider whether the provisions of the Order should be continued in force indefinitely.

During the period of the Experimintal Order, any objections or representations should be sent in writing to the undersigned.

A copy of the Experimental Order together with a map indicating the location and effect of the Order, together with a statement setting out the reasons for proceeding by way of experiment, may be examined during normal office hours at the Secretary's Department, London House, 5-11 London Road, Maidstone, Kent ME16 8HR.

If you wish to question the validity of the Experimental Order, or of any provisions contained in it, on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or of any Instrument made under it has not been complied with in relation to the Experimental Order you may, within 6 weeks from 11th April 1990, apply to the High Court for this purpose.
