THE NOTTINGHAMSHIRE COUNTY COUNCIL (MILTON STREET, NOTTINGHAM) (BUS STOP CLEARWAY) ORDER 1990 (46)

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council propose to make an Order under sections 1 and 3(1) of the Road Traffic Regulation Act 1984, as amended, the effects of which will be (respecting roads in the City of Nottingham):— To create a “Bus Stop Clearway” whereby at certain designated bus stops all vehicles, except buses, will be prohibited from waiting, loading and unloading between the hours of 7 a.m. and 7 p.m. in the following lengths of road:— (1) Mansfield Road, east side, from a point opposite the northern kerb line of Peachey Street in a southerly direction to its junction with Milton Street. (2) Milton Street, east side, from its junction with Mansfield Road in a southerly direction to its junction with Lower Parliament Street.
