The Ogwr Borough Council (Nanthir Road, Blaengarw, Mid Glamorgan) (Stopping-up) Order 199

The Secretary of State for Wales hereby gives notice that he proposes to make the above Order under section 211 of the Town and Country Planning Act 1971 to authorise the stopping-up of the highway described in the Schedule to this notice to facilitate the movement of traffic and in the interests of the safety of users of the main highway which is to be constructed in accordance with planning permission granted by Ogwr Borough Council on 10th November 1988.

The highway to be stopped up is at Blaengarw in the County of Mid Glamorgan. It is shown by zebra hatching on the deposited plan and is that length of highway known as Nanthir Road which extends from its junction with Bridge Street in a general north-easterly direction for a distance of 26 metres.
