Notice of Public St. Nicholas Square Public Paths: Stopping-up Orders, (Nos. 1, 2 and 3) 1990

Notice is hereby given that, the above-named Orders (hereinafter referred to as 'the Orders') made on 12th April 1990, are about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed by Lancaster City Council as unopposed Orders.
