

## KINGSTON UPON HULL CITY COUNCIL

*The County of Humberside (Kingston upon Hull) (Holderness Road) (Prohibition of Driving) Order 1990*

Notice is hereby given that the Kingston upon Hull City Council on 25th April 1990, made the above Order under the Road Traffic Regulation Act 1984. The Order will come into operation on 30th April 1990.

The effect of the Order is to prohibit vehicles from proceeding through the central reservations opposite numbers 625 and 627 Holderness Road, and number 607 Holderness Road.

## KINGSTON UPON HULL CITY COUNCIL

*The County of Humberside (Kingston upon Hull) (Holderness Road/Lake Drive) (Prohibition of Right Turn) and (Prohibition of U Turn) Order 1990.*

Notice is hereby given that the Kingston upon Hull City Council on 25th April 1990, made the above Order under the Road Traffic Regulation Act 1984. The Order will come into operation on the 30th April 1990.

The effect of the Order is to:

- prohibit vehicles from making a right turn from Holderness Road, into Lake Drive, and
- prohibit vehicles proceeding along the northernmost carriageway of Holderness Road, to make a U-turn through the gap in the central reservation opposite its junction with Lake Drive.

*The Lancashire County Council (Exemption for Buses Amendment) Order 1990*
