

COLCHESTER BOROUGH COUNCIL

The Colchester (Off-street Parking Places) (General) Order 1990

Notice is hereby given that the Colchester Borough Council propose to make an Order under section 35 of the Road Traffic Regulation Act 1984, the effect of which is to regulate the use of the public car parks at the locations specified below and to specify the charges to be paid for the use of the car parks, the maximum time for which vehicles may wait and the class of vehicles which may use such car parks. The Order revokes the Colchester (Off-street Parking Places) (General) Order 1988 as varied and revokes the Colchester (Off-street Parking Places (Queen Street Temporary Car Park) Order 1979.

For all car parks except Victoria Esplanade—West Mersea, Sheepen Road, as set aside for heavy vehicles, Queen Street Temporary, St. John's, St. Mary's and Queen Street multi-storey car parks, there will be no charge:

- (a) between the hours of 9 p.m. and 6 a.m. Mondays to Saturdays;
- (b) throughout Sundays and Public Bank Holidays;
- (c) for motor cycles.

Except where mentioned, all car parks listed below are limited to use by motor cycles, motor cars and invalid carriages and motor vehicles constructed or adapted solely for the purpose of carrying goods but not exceeding 30 cwt. unladen weight.

At Vineyard Street, the charge will be 50p for 2 hours or lesser period, the maximum. No return within 30 minutes of leaving. No season tickets.

At Priory Street, Sheepen Road, Royal London Insurance (Middlesborough), St. Botolphs and Britannia Surface the charge will be 70p; in each case for any period within 5 hours or less. Quarterly or Annual season tickets will be available in each case. At London Road, Lexden car park there will be no charge but the maximum period for which vehicles may be wait is 2 hours. There is also a charge at Priory Street of 50p for the first 2 hours or less and a charge of £1.20 for any period of 10 hours and £1.90 for 15 hours at St. Botolph's, Britannia Surface and Sheepen Road car parks.

Sheepen Road car park is also available for vehicles over 30 cwt. unladen weight at £1.50 for 5 hours or less with no season tickets.

The Victoria Esplanade—West Mersea car park is open every day on and from Easter Saturday until 30th September in each year at a charge of 40p for all day or part thereof on Saturdays, Sundays and Bank Holidays from Easter Saturday until 30th June and during September. Every day during July and August is at a charge of 60p per day or part thereof. All other days free of charge. A season ticket is available. The maximum period of waiting is until midnight on day of arrival. Trailers are not permitted. Motor cycles—no charge.

At St. John's, St. Mary's and Queen Street multi-storey car parks the charges will be:

Not exceeding 1 hour—30p	6 hours—£1.70
2 hours—55p	9 hours—£2.30
3 hours—80p	24 hours—£3.30
4 hours—£1.10	Parking overnight—50p

Quarterly season tickets will be available.

At Queen Street temporary car park, the charge for all vehicles will be up to 20 minutes waiting 20p; stops in excess of 20 minutes but not exceeding 3 hours £2.50; not exceeding 6 hours £6 and stops in excess of 6 hours up to midnight on day of arrival £10—no season tickets.

Except for Vineyard Street, London Road, Lexden, Queen Street temporary and Victoria Esplanade—West Mersea car parks, the maximum period for which vehicles may wait at all the other car parks is 24 hours.

The Excess charge is increased to £18 payable within 28 days or £6 within 7 days.

A copy of the Order as drafted, a map indicating the position of the car parks referred to in the Order and a copy of the Council's statement of reasons for proposing to make this Order may be inspected at Angel Court, High Street, Colchester—Mondays to Thursdays, 9 a.m. to 5 p.m.; Fridays, 9 a.m. to 4.30 p.m.
